

She began her career in residence life, first at Stonehill College and then at Wentworth Institute of Technology, where she ultimately served in the role of Associate Director for Housing & Residential Life.

In 2001, Pauline returned to Stonehill College as the Director of Residence Life. Since that time, she has assumed positions of increasing responsibility at Stonehill and was recently appointed the Vice President for Student Affairs. In her position at Stonehill, she is responsible for overseeing the Offices of Community Standards, Counseling Services, Health Services, Intercollegiate Athletics, Intercultural Affairs, Recreational Sports, Residence Life, and Student Activities.

During her professional career, Pauline has always placed great emphasis on giving back to the field through her work within professional organizations. She served on the Boston Area College Housing Association (BACHA) Steering Committee from 1996-2002, assuming the role as President from 2000-2001.
